Twins' trade talks with Colorado personal clear at least for a couple weeks One of the reasons why the Twins probably won't make a trade on July 31, or even August 1, is that their one-time lead deadline trade negotiator, Susan Slusser, has been temporarily reassigned as special assistant to the president for the Twins. Team sources said that move was temporary while Slusser's departure from her trade bureau job "was finalizing." She's been back in the Twins front office since last Wednesday, after taking maternity leave from her position with Bill Smith's Red Sox, which was finally a done deal. Both the Twins and the Rockies have had two different conversations with one another in the last couple weeks. One of them has been verbal, the other has been mostly by email. One of the concerns brought up by the Twins has been whether the Rockies would be willing to do a one-for-one swap of their top draft picks (right now it's the 10th overall and the third-overall pick), because the Twins, according to sources, would likely do one or two deals to get a key piece with the trades moving through the Colorado front office. The Twins' top prospect is pitcher Gabriel Moya. It's clear that Colorado's top prospect is starting pitcher German Marquez, who signed with d0c515b9f4
