Shear, for appellants. Perry, Walters & Langstaff, J. M. Langstaff, for appellees. GRICE, Justice. The First National Bank of Boone County and Continental National Bank, as executors of the estate of Mattie E. Peacock, filed a petition in the Superior Court of \*409 Columbia County (in which the will of Mattie E. Peacock was probated) alleging that one Floyd Randolph, who was their predecessor in title, executed and delivered to them a written release of any and all claims for which Mattie E. Peacock might be liable and that they paid him \$15,000 therefor. They prayed that the petitioners be ordered to execute a new written release of any and all such claims and for judgment against Mattie E. Peacock for the full amount of such release and that the respondent be restrained from prosecuting any suit of any character on the alleged claim against them on which the release was made. The respondent filed a traverse denying that the release was valid and denied that he was indebted to Mattie E. Peacock. Attached to the traverse were the verified records of the Superior Court of Columbia County showing the probate of the will of Mattie E. Peacock and the approval of the will by the probate court. The petitioners filed a motion for judgment on the pleadings. The court sustained the same. This appeal by the respondent followed. Held: 1. The petitioners rely upon Code Ann. § 108-503, which reads: "In an action for the recovery of real property, or of an estate or interest therein, or for the foreclosure of a mortgage, or of an equity of redemption therefrom, or for the re-establishment of any lien upon real property, the plaintiff shall, at the time of the commencement of his action, make out a good and sufficient title to the real property or estate or interest therein claimed by him, or have it in him at the time of the commencement of his action. No judgment or decree shall be entered against any defendant except upon his appearance or
