Appellants cite Allen v. State, 467 S.W.2d 629, 630 (Tex.Civ.App.1971); Stiles v. Gilbert, 489 S.W.2d 831, 833 (Tex.Civ.App.1972); Moore v. State, 394 S.W.2d 895, 899

(Tex.Civ.App.1965). These cases are clearly inapposite here since they all dealt with the interests of children.<sup>11</sup> In the light of the entire record in this case we conclude that the trial court did not err in striking the witness Nunn's testimony.<sup>12</sup> Appellants also contend that the district court erred in taxing them with costs amounting to \$2,411.69 because no proof of taxable costs was offered by appellee.<sup>13</sup> Rule 54(d) F.R.Civ.P., 28 U.S.C., provides in pertinent

part: 14 'Costs. Except when express provision therefor is made either in a statute of the United States or in these rules, costs shall be allowed as of course to the prevailing party unless the court otherwise directs; but costs against the United States, its officers, and agencies shall be imposed only to the extent permitted by law.' 15 The appellee, in his cross-appeal, contends that the district court erred in failing to award him fees for his expert witness fee as

provided in 28 U.S.C. 1821(b)2. Although appellee in his brief filed here states that the statute provides \$5 per day for the first day and \$2 per day for each additional day, he has not cited any cases construing this statute.

Appellee also failed to file a brief on appeal. Fed.R.App.P. 18(1). The Government contends that the statute was inapplicable here since the witness was not an officer or agency of the United States.

Category:Photographic collections Category:Landscape photographyQ: Modular arithmetic and the alphabet Let  $A = \{a, b, c, d\}$  and  $N = 2^4 - 1 = 15$ . Now let  $G = \langle a \rangle$  and  $H = \langle b \rangle$ . Since  $N$  is a power of  $2$  so  $\gcd(N, G) = \gcd(N, H) = 1$ . Note that  $\gcd(15, G) = 2$ ,  $\gcd(15, H) = 3$  and  $\gcd(15, G \cup H) = 1$ . We want to show that  $N = 15$  is an integral multiple of  $G$ . So we have that  $\gcd(15, G) = 2$  implies that  $\gcd(15, G \cup H) = 1$  (since  $G \cup H = A$ ) so  $15 = a^4 + b^4 + c^4 + d^4$  and  $a + b + c + d = 15$ . How can I show that a multiple of  $G$  is integral? A: By Cauchy-Dickson's theorem, the order  $N$  is prime to  $G$ , hence  $N$  is prime to  $G$  and  $H$ . If  $\ell$  and  $m$  are two relatively prime integers, then  $k = \ell^{-1} \cdot m$  is also relatively prime to both  $\ell$  and  $m$ . This implies that  $N$  is the only common multiple of  $G$  and  $H$  (since they are both relatively prime to  $N$ ) and that the two groups have no common multiple. Assume  $15 = a^4 + b^4 + c^4 + d^4$  for some integers  $a, b, c, d$ . Since  $a, b, c, d$  are elements of  $A$ ,  $a$  must be equal to some  $d$ , and similarly for  $b$  and  $c$ . Hence  $a = d = 1$ .
